**AGREED ORDER APPROVING AND RATIFYING JOINT MOTION TO SEAL  
FINANCIAL INFORMATION**

**THIS CAUSE** came before the Court on the parties' Joint Motion to Seal Financial Information (Filed January 31, 2024) and the Court having reviewed the Motion and Court file and being otherwise fully informed finds as follows:

A. Pursuant to Florida Family law Rule of Procedure 12.400 (d)(1) this court has the authority to conditionally seal the financial information required by rule 12.285 if it is likely that access to the information would subject a party to abuse, such as the use of the information by third parties for purposes unrelated to government or judicial accountability or to first amendment rights.

B. As a result of the agreement of the parties as to the confidentiality of the Confidential Records and the Court's review of the Unopposed Joint Motion, the Court determines in its discretion that a hearing on the Unopposed Motion is not necessary.


C. The Clerk of the Court is directed to publish the order in accordance with Florida Rule of Judicial Administration 2.420(e)(4).

It is therefore

**ORDERED AND ADJUDGED** as follows:

1. The Joint Motion to Seal Financial Information is **GRANTED**.
2. The court records indicated in the parties' Joint Motion to Seal Financial Information, including but not limited to Financial Affidavits, any agreements, and order or judgments which contain financial information, the parties' marital settlement agreement and equitable distribution worksheet, are hereby to be made confidential and sealed from the public.
3. The Clerk of Court is hereby directed to comply with this order and the requirements set forth in Rule 2.420, Florida Rules of Judicial Administration, for purposes of maintaining the confidentiality of the Confidential Records pending further order of this Court.
