

2. The Court has determined that Petitioner's Exhibit 4 is confidential, in its entirety.
3. The degree, duration, and manner of confidentiality ordered by the Court is no broader than necessary to protect the interests set forth in Rule 2.420(c)(9)(A)(vi) and (vii) of the Florida Rules of Judicial Administration and Rule 4-1.5(f)(4)(B)(ii) of the Rules Regulating the Florida Bar and there are no less restrictive measures available to protect the interests set

forth in Rule 2.420(c)(9)(A)(vi) and (vii) of the Florida Rules of Judicial Administration and Rule 4-1.5(f)(4)(B)(ii) of the Rules Regulating the Florida Bar.

It is thereupon, ORDERED AND ADJUDGED:

1. The Motion to Seal Petitioner's Exhibit 4 is **GRANTED**;
2. **THE CLERK OF THE COURT** shall keep Petitioner's Exhibit 4 (entered into evidence June 17, 2025) under SEAL until further order of the Court.
3. **THE CLERK OF THE COURT** is directed to publish this Order in accordance with Rules of Judicial Administration, Rule 2.420(c)(4).
