- F. The degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests of the minor children, and no less restrictive measures are available.

ORDERED AND ADJUDGED that:

- 1. The Respondent's Unopposed Motion to Determine Confidentiality of Court Records and Sealing Court File is GRANTED.
- 2. The Clerk of Court is hereby directed to seal the Court file in Case No. 2023-DR-003839-O.
- 3. The Clerk of Court is further directed to publish this Order in accordance with Rule 2.420(e)(5), Fla. R. Gen. Prac. & Jud. Admin.
